New Alarm Ordinance to Go Into Effect June 1, 2018

During 2017, 90 False Alarms requiring emergency response were reported out of 90 Total Alarms (100%). As of April 2018, 29 False Alarms were reported out of 30 Total Alarms (96%). In an effort to cut down on false alarms requiring emergency response, the City Commission approved Ordinance 1712 on April 16, 2018. Here's what you need to know:

- Individuals and businesses shall be required to register their alarm system with the City beginning June 1, 2018
- Applications for an alarm permit will be available at the Police Department
- A one-time fee of \$25 will be assessed
- There will be no charge for annual renewals
- A City inspection must be completed before a permit can be issued
- A sticker will be provided to permit recipients to place on their front door
- After the third false alarm, fees will be assessed on an increasing scale for each false alarm thereafter
- Emergency Services will always respond to alarm signals, regardless of false alarm history

Similar ordinances have been shown to drastically reduce the number of false alarms in other communities. For further details and a full-text copy of Ordinance 1712, please contact the City Office.

Information on Industrial Revenue Bonds

On April 16th, The Goodland City Commission unanimously approved the issuance of Industrial Revenue Bonds (IRBs) for a new hotel project in Goodland. Leading up to the meeting, there was some confusion regarding what an IRB is. Here are the basics:

- IRBs are one of the most popular and cost-effective Economic Development tools in a City’s toolbox.
- IRBs are used in Kansas to finance acquisition and construction of a broad variety of industrial and commercial properties.
- IRBs require a governmental entity to act as the “issuer” of the bonds, who will hold an ownership interest in the property for as long as the IRBs are outstanding.
- The issuer is a passive conduit whose role is essentially to lend its status as a municipal corporation to the transaction.
- There is never any obligation for the issuer/City to pay bondholders, and therefore no risk to taxpayers.
- The issuer can provide property tax exemptions and sales tax exemptions on construction materials for the project.
- Whenever tax exemptions are anticipated, a Cost-Benefit Analysis must be provided to prove the project’s value and return on investment.
